38 VILLAGE ISSUES

Broadband

OCC are considering possible solutions to the provision of broadband to Bainton. Grants of £7000 are available, but there needs to be sufficient interest in the service. Currently there are 11 interested parties, subject to confirmation from OCC of costs involved.

Allotments

No current issues.

East/West Rail

The road to Poundon though Stratton Audley Park will be closed most of November to allow for the creation of HGV passing bays. The Clerk was asked to raise Parish concern about the speed of traffic through the top of the village with OCC and suggest traffic calming measures and a VAS.

Lone Barn

The rocks outside this property have been removed, but the verge appears to have been raised. The Clerk was asked to refer the issue to OCC.

HS2

Construction work has now started in the area, and local grants are available. The Clerk will send HS2 contacts to the playing field committee, as there is a need to repair and upgrade the play equipment.

Baynards Green

The Parish Council has responded against proposals in to CDC's local Plan review, to designate additional warehousing at Baynards green Concern was also expressed at the large quantity of litter in the area of the MacDonald's drive through restaurant.

The Parish Council agreed to support the reasonable cost of proposals to cut the hedge around the playing field. Cllr Barnes agreed to pursue this in conjunction with Kelly Holden White and Julie Adams.
