OCC and CDC are working together on a re start and recover review, part of which will look at savings but changing ways of working.

OCC and District Councils are looking at options for Local Government reform.

The Dorchester masterplan will require a new layout of junction 10 of the m40.

The Council is looking for ways to recognise community volunteers, who have provided support during the lockdown.

News of the Oxford to Cambridge Expressway is awaited.

Q What is Dorchester? A the development at Heyford

Q Will reform be just Oxfordshire?

A yes, but there may be a recognition of the need for links between Oxford and Cambridge. Q Could he chase clearance of the obstruction outside Lone barn.

Cllr Corkin may have sufficient monies in his Priority Fund to support WIFI in the Church.

38 VILLAGE ISSUES

Broadband

Cllr Davies reported that fibre to the cabinet in Bainton has not proved possible. The County is therefore planning to install fibre to the property, hopefully within 12 months.

Allotments

The rat problem has been resolved.

East/West Rail

Work has now started and LGVs will be using the Stratton Audley Road through the top of the Village. The Clerk was asked to approach the developers to see whether they could mitigate the effects by the installation of a VAS.

Oxford to Cambridge Expressway

Ongoing.

Lone Barn

The verge outside this property is still built up on both sides of the road, and the obstruction is difficult to see at night, and presents a dangerous road narrowing. Cllr Corkin has been asked to chase OCC action, on receipt of photographs.

CDC will be holding a virtual Parish Liaison Meeting on 30th July.

40 ANY OTHER BUSINESS

The Parish Council agreed to a request by a resident to hire the marquee, subject to compliance with Government guidance on managing COVID 19 risks.
