### **Broadband**

Broadband for Bainton is progressing slowly, but it is hoped that the service will be available from Summer 2024. The provider is currently checking the suitability of existing pipework.

### **Defibrillator**

The Clerk was asked to investigate options for a defibrillator for Bainton.

### **Concrete base**

The Parish Council agreed to consult the village on the future of the concrete base by the recreation ground.

### **Bench outside Lower farm**

The Parish council agreed to relocate the bench recently purchased to the recreation ground, and purchase another bench to be installed by Lower farm. The Clerk was also asked to look for new rubbish bins for the Recreation ground.

### **Fast food litter**

Cllr Simpson agreed to raise the Parish Council's concerns with CDC planners, as the local fast food outlets do not appear to be taking any action to clear up the litter caused by their activities.

### **20mph**

The Clerk was asked to check the signage of the 20mph zone, particularly by the Peyton Arms.

### **Weight restriction sign**

It was reported that the weight restriction sign on the Stratton Audley road needs replacing. Cllr Simpson reported that OCC are now working on a HGV strategy for the whole county.
